Sir I have a copy of the Appendix filed in Appellate case Number 2011-195272. (Sir I tried to file some pro-se letters, etc with the S.C Supreme Court in reference to Appellate Case 2011-195272. You sent me a response letter informing me that not action will be taken on my pro-se filings because I was represented counsel. You never returned my pro-se filings to me. Sir can you please return all my pro-se filing to me. One of those Pro-se filing I was trying to show the S.C Supreme Court, Misconduct and Fraud upon the Court, in which I included documentation of proof being a copy of assistant Attorney General William M Blitch Jr mail log from April 21, 2011 to June 15, 2011. a copy of Assistant attorney General William M. Blitch Jr. June 15, 2011 expedited Motion to recall the remittitur, and a copy of the S.C Court of Appeals June 30, 2011 order recalling the remittitur. You kept these documents or exhibits that I included with my pro-se filings. Sir will you please return a copy of everything filed to me. I need them to show I attempted to present those issues to the S.C. Supreme Court, to the Federal Court.

Also Sir you have the power to obtain records from the S.C. attorney General's office. In reference to Appellate Case #2008104666 S.C. Court of Appeal sent to Assistant Deputy attorney General Salley W. Elliott on April 21, 2011 a copy of its Filed order denying the S.C. Attorney General's office March 21, 2011 Petition for rehearing. The S.C. Court of Appeals file April 21, 2011 order denying Petition for rehearing consists of 2 pages a cover letter and

The actual April 21 2011 Filed order denying Petition for a Rehearing. Assistant Deputy Atty General Salley W. Elliott, held on to the cover letter and order denying Petition for a rehearing, but it just wasn't forwarded to Assistant Atty General William M Blich Jr in time for him to comply with SCAOR 242(c) filing with a petition for a rehearing. Having not received the filing of a petition for writ of Certiorari, the S.C. Court of Appeals on June 2nd 2011 sent the remittitur. You will find that a copy was received by the SC attorney General's office on June 3, 2011 and passed onto assistant Atty General William M Blich mail log on June 3 2011 on June 14 2011 I was released from SCDC into the custody of Greenville Court Detention Center for medical. On June 15, 2011 logged on assistant Atty General William M. Blich mail log is a Order Denying Petition for Rehearing for Robert Watkins. I requested a copy of that order denying petition for rehearing for Robert Watkins so I can see the actual date that S.C. Court of Appeal April 21, 2011 filed order Denying Rehearing was received by the Attorney General's office, pursuant to Sec F.O.I.A. a copy was sent to me but, it wasn't endorsed with the date received by the attorney General's office. After several request, I was told no such received order denying Rehearing existed, which was true. The actual order was not endorsed with the date the order was received by the Atty General office, because it was the second page. The cover letter was the first page, which would have been the page endorsed with the date the order was received by the attorney General's office. So when I requested for a copy of the cover letter that was attached to the order denying Rehearing for Robert Watkins, that would show the date received. The SC Atty General's office would not respond to my request for the received cover letter that was attached to the SC Court of Appeal April 21, 2011 filed order denying Rehearing. As a government official, the Atty General office will provide you a copy of the received cover letter and April 21 2011, filed order denying petition for a Rehearing that is logged in on assist Atty General William M Blich Jr mail log on June 15, 2011, and make it available to me.

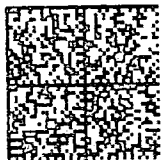
