PETITION FOR REHEARING

---

Pursuant to Rule 221 of the South Carolina Appellate Court Rules, Respondent, Jean P. Derrick, by and through her undersigned counsel, files this petition for rehearing, for the purpose of asking the Court of Appeals to correct one reference in its decision of this case, Published Opinion Number 5618, filed January 23, 2019.

In the last paragraph of page two of the opinion, the Court correctly recited the counterclaims asserted by Appellant, Lisa C. Moore, against Respondent in the answer and counterclaim filed in the lower court. In the last paragraph on page five of the

opinion, the Court stated, "Client will still be able to litigate her counterclaims for potential malpractice and unfair trade practices against Attorney, as they are still under the jurisdiction of the circuit court."

Respondent respectfully petitions the Court to delete from this sentence the reference to the counterclaims as claims "for potential malpractice." No claim for legal malpractice has been filed by Appellant against Respondent, and therefore no claim for legal malpractice is within the jurisdiction of the circuit court. *See Answer and Counterclaim of Defendant, Record on Appeal, pages 40-46.* Respondent respectfully suggests that the sentence quoted above be corrected to read as follows: "Client will still be able to litigate her counterclaims against Attorney, as they are still under the jurisdiction of the circuit court."


