I hope this finds you well. Our office represents the Appellant the Charleston County School District (the "Appellant") in the above-referenced matter.

Appellant's Notice of Appeal in this matter was filed and served on January 24, 2019. By letter dated January 25, 2019, our firm ordered the transcript from the circuit court hearing court reporter. On January 29, 2019, the court reporter confirmed via e-mail that the transcript ordered and received by Appellant in December 2018 (prior to the entry of the circuit court's final orders) was in fact the official, certified transcript for the purposes of this appeal. As such, Appellant is treating January 29, 2019 (the date of transcript confirmation) as the trigger for the 30-day period for Appellant to file its Initial Brief per Rule 208(A)(1), SCACR. That would make Appellant's Initial Brief deadline February 28, 2019.


By the above analysis, the Appellant's Initial Brief is currently due on February 28, 2019. Pursuant to Rule 263(b), SCACR, we respectfully request a 30-day extension of time in which to file the Initial Brief, making it due on Monday, April 1, 2019 (March 30, 2019 is a Saturday).
