Dear Clerk Kitchens:

Yesterday, I placed a call to the court. You were not in; but the new case worker Mary Catherine Singleton was available. She asked me to clarify the status of the case based on my submissions. She informed me that the prior case manager had left and that some confusion had occurred within the office as to filings; particularly ones that I made that have not been entered into C-track, cross correspondence that had been sent to the wrong address because of a lack of address change on a timely basis.
