Furthermore, the Defendant shall maintain regular contact with his attorney.


The Bench Warrant is hereby lifted and vacated with the aforesaid conditions made part and parcel of the Defendant's bond.



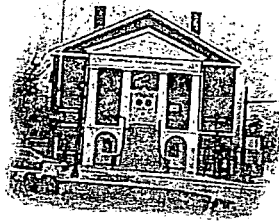

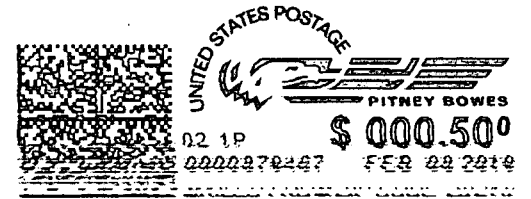
