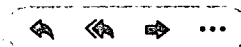
Thank you Ms Angela P. Berry

This is to acknowledge that I received your letter requesting the Transcript of Record in the above matter. I have reviewed my records and estimate that your transcript will be 20 pages.




