I received a letter from your office dated Dec. 10 2018 stating that my petition for writ of certiorari was granted and that my attorney is now briefing the issues on appeal and once a decision is reached on the merits of my case that you'll notify my attorney. I'm confused on how I'm getting two separate versions on my case. My brief was granted & filed on Sept. 24 and signed by you and then I received a letter from Ms. Hackett stating that the state had until Oct 24 to answer the brief. This never happened and I hadn't heard anything from anybody until Jan. 16, 2019 a letter from you dated Dec. 10. On Jan 11, 2019 I spoke with Ms. Hackett and she not said anything about my case brief or anything close to that what she did say is that the state was giving me a limited remand for specific findings as to whether I knowingly, intelligently and voluntarily waived my right to raise post-conviction relief claims independent of my request for a belated Appeal (NO I didn't)

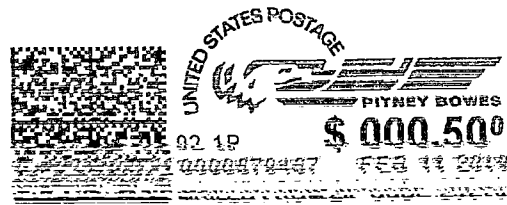
Why would I? The only reason that my post conviction relief was dismissed with prejudice is because Judge Earl, the Chief Judge at the time was my Criminal Judge and he also wanted to be my PCR Judge as well (Conflict of interest) back in Sept. 2015 my case was in remittitur He was still in office and I never heard anything back because he blocked that. This case shouldn't have made it into any courtroom with unprovable Indictments, No Affiant, No witnesses, No physical or Circumstantial evidence and for a charge of Burglary in the first. The state has to first place you inside. Second someone has to dwell there and all the elements has to be met. None of them were met. "No burglary" No Victim no crime

I've been here for 4 years on a Level 3 yard even though I'm MI 2 for a crime that never happened. I have not received any relief and basically no help from Indigent defense S. Hockett the only spoken to her twice in 3 1/2 years and when I have spoken to her its never good Its always something that I be alone or its

something negative to keep my spirit  
down. I have not done anything  
this entire time I've been locked  
up during the 1 day trial I never  
took the stand, made no statements  
and I have no criminal history  
on doing anything close to this I  
didn't sign anything or took no plea  
and the state with none of the  
elements being met got a conviction  
with nothing to help them proving  
me guilty besides Judge Early in  
which he permitted all this illegal  
activity in his courtroom he also  
stated in open court that the  
asst. Solicitor and the asst. Public  
defender they all work in the  
same office for him. Also he  
excused the jury twice so they  
couldn't hear the officers excuses  
about how they couldn't prove they  
advised me of my miranda rights.  
The jury of my peers consisted of  
8 white women 4 black women 2 white  
men. (I was guilty before the trial  
started) I got my case (True Billed)  
(written in not stamped) on July 2, 2015  
which was on a thursday and then

The grand Jury met again on July 6, 2015 present upon their oath without general sessions being in neither time because in the 2nd Judicial Circuit the only times they both meet is in Jan. May. Oct. unless a special session is called by the Chief Justice of the Supreme Court. So this couldn't have been a lawful meet. The 6<sup>th</sup> of July was a Monday on Tues the 7<sup>th</sup> they had Jury selection and the trial started the same day the next day on the 8<sup>th</sup> trial was over and on the 10<sup>th</sup> I was in prison. The paper work can't possibly move that fast. I know I've written alot but I wanted to outline my case for you so you can see why I'm so miserable and not understanding why I'm still in prison when everybody know that I'm innocent and why do I keep getting the runaround for the past 4 years. Feel free to check everything out. Please do something to help me to get out of here and back to my family. Hearins, New Trial, anything I don't care!
