## APPELLANT'S MOTION FOR COSTS

### I. INTRODUCTION

At the end of this court's per curium revised opinion dated January 16, 2019, the court stated that:

**"This case is concluded. "**

However, Respondents<sup>1</sup> continue to seek relief from this court, by seeking Costs.

Based on the principles in Rule 222, SCACR, this Court has authority to award costs to Appellant Lisa Fisher (and Betty Fisher, by her joinder) as follows:

"...When an appeal is affirmed or reversed in part or is vacated, **costs shall be allowed only as ordered by the appellate court.**" (Emphasis added)

Appellant Lisa Fisher ("Appellant") has filed a single opposition to the two motions for costs filed by Respondents' counsel which set forth the prejudice and harm that Appellant has suffered by this case. The underlying case was brought for the benefit and on behalf of her great aunt Alice Shaw Baker.

Respondents should not profit further in this case, as they refused to help Alice Shaw Baker in her final days, and based on this court's decision in the related case, 2017-000743, Appellant Lisa Fisher was the only person not compensated for her work--she was forced into indentured servitude for her great aunt and for the unintended benefit of Respondents.

<sup>1</sup> Respondents refer to Bessie Huckabee, Kay Passailaigue Slade and Sandra Byrd and Bessie Huckabee as personal representative of the Estate of Alice Shaw Baker, herein "Respondents".

For all these reasons as set forth below, further sanctions, by way of costs against Appellant, is a wrong that should not be permitted. However, as set forth in the sworn statement, the Appellants in this case incurred costs in excess of \$5,835.80. Due to the fact that the Appeal was necessary to overcome errors in law, including the sanctions awards against Appellant and her mother, costs should be awarded to Appellant, or at the very least Betty Fisher.

### **RELIEF SOUGHT**

**WHEREAS**, the decision of the trial court was reversed in part and affirmed in part by the South Carolina Supreme Court in its per curium opinion revised on January 16, 2019.

The Supreme Court issued the Remittitur on February 1, 2019.

Appellant moves this Court tax costs on appeal against Respondents pursuant to Rule 222, SCACR. Appellant requests that the following costs be taxed against Respondent:


1. Costs for Printing of the Briefs and Record;
2. Costs for transcripts;
3. Filing fees;

Wherefore, the Appellant Lisa Fisher prays that costs on appeal in the amount of \$5,835.80 be taxed against the Respondents, Bessie Huckabee, Kay Passailaigue Slade, Estate of Sandra Byrd, in the matter of Estate of Alice Shaw Baker, for the benefit of Appellant Lisa Fisher and/or as requested by Joinder of Betty Fisher.

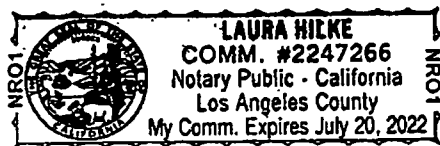



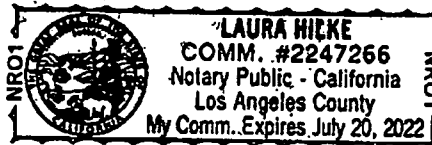

## INSTRUCTIONS

The wording of all Jurats completed in California after January 1, 2015 must be in the form as set forth within this Jurat. There are no exceptions. If a Jurat to be completed does not follow this form, the notary must correct the verbiage by using a jurat stamp containing the correct wording or attaching a separate jurat form such as this one with does contain the proper wording. In addition, the notary must require an oath or affirmation from the document signer regarding the truthfulness of the contents of the document. The document must be signed AFTER the oath or affirmation. If the document was previously signed, it must be re-signed in front of the notary public during the jurat process.

- State and county information must be the state and county where the document signer(s) personally appeared before the notary public.
- Date of notarization must be the date the signer(s) personally appeared which must also be the same date the jurat process is completed.
- Print the name(s) of the document signer(s) who personally appear at the time of notarization.


