TO: THE HONORABLE JUDGES OF THE SOUTH CAROLINA SUPREME COURT

COME NOW Respondents Mansour Rashtchian and Amy Rashtchian, by and through their undersigned counsel, to respectfully request an Order from this Court taxing the costs associated with responding to the appeal against the Appellants pursuant to Rules 222 and 242 of the South Carolina Appellate Court Rules.

The instant lawsuit was filed on April 24, 2013, tried to verdict in December 2014, and the verdict for the Respondents was affirmed by the Court of Appeals on or about February 1, 2017. This Court granted Certiorari and filed the Remittitur on February 6, 2019.

Rule 242(j)(1), SCACR provides, “[u]nless otherwise ordered by the Supreme Court or agreed to by the parties, costs shall be assessed against the appellant if the decision of the Supreme Court has the effect of affirming the judgment of the lower court or tribunal which was reviewed by the Court of Appeals.” Under the rule, “[t]he party entitled to recover costs may recover all those costs specified in Rule 222(b), to include the attorney's fee provided by that rule.”


Rule 222(a), SCACR provides, “[u]nless otherwise ordered by the appellate court or agreed by the parties, costs shall be taxed against the appellant when the appeal is dismissed or judgment on appeal is affirmed.” Under the rule, “[t]he party entitled to recover costs under this rule may, to the extent the party actually incurred these costs, recover the following: ... (5) the cost of printing the party's final brief(s) under Rule 210 ... [and] an attorney's fee in an amount which shall be set by order of the Supreme Court.” Rule 222(b), SCACR.

“Additionally, the party may, to the extent the party actually incurred these costs, recover: ... (3) the cost of printing the party's brief(s) under Rule 242(i). ... [and] an

additional attorney's fee in an amount which shall be set by order of the Supreme Court.”
Rule 242(j), SCACR (emphasis added).

Respondents hereby request an Order granting the cost of printing the Final Brief of Respondents for the Court of Appeals, \$53.17¹; reimbursement of a portion of the Attorneys Fees, \$1,000.00² at the Court of Appeals; the cost of printing the Final Brief of Respondents for the Supreme Court, \$114.80³; reimbursement of a portion of the Attorneys Fees, \$1,000.00⁴ at the Supreme Court; for a total of \$2,167.97 and any additional amounts this court deems necessary and proper in light of the circumstances.

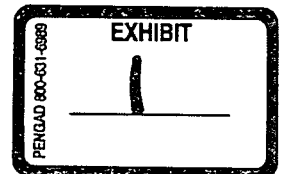

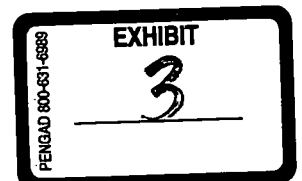
