Counsel filed the petition for writ of certiorari with the accompanying appendix in the case of Joshua A. Reed v. The State with the Supreme Court on November 26, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Terrance L. Bland with this Court on November 16, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of In the Interest of Zahi H., a Juvenile Under the Age of Seventeen with this Court on November 16, 2018.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by the counsel below, counsel for the state graciously consents to or does not oppose this request.


