
Dear Ms. Abbott Kitchings:

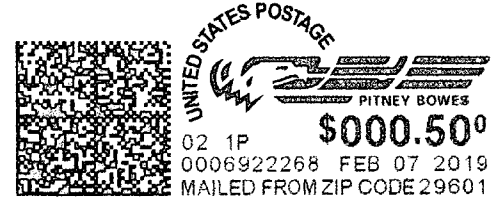
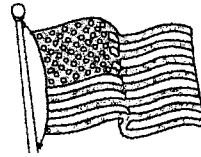
