the 7 or 8 years but at the end I got 15 years,

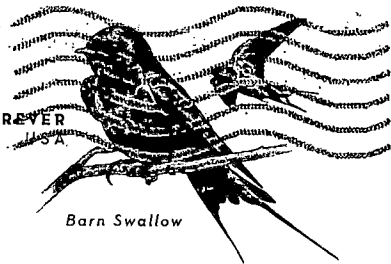
So now that you have my pro se brief may
