**RESPONDENT/APPELLANT ENCORE TECHNOLOGY GROUP, LLC'S  
THIRD MOTION FOR EXTENSION**

Respondent/Appellant Encore Technology Group, LLC ("Encore") requests an additional 14-day extension of time to submit its initial brief and designation of matter to be included in the record on appeal in the above-referenced case, which are currently due on February 27, 2019, and that this deadline be held in abeyance during the pendency of this motion.

This case is a consolidation of three separate appeals. Encore received the trial transcript from the court reporter on November 26, 2018. Because of previously scheduled holiday travel plans, on December 12, 2018, Encore filed its First Motion for Extension of time to submit its initial brief and designation of matter to be included in the record on appeal, which the Court granted. Because of the complexity of this appeal and the volume of the trial transcript, on January 14, 2019, Encore filed its Second Motion for Extension of time to submit its initial brief

and designation of matter to be included in the record on appeal, which the Court also granted, noting that no additional extensions would be granted absent extraordinary circumstances.

On February 19, 2019, counsel for Appellants/Respondents Keone Trask and Clear Touch Interactive, Inc. f/k/a Clear Touch Interactive, LLC, filed a Third Motion for Extension of Time requesting an additional fourteen days to file their initial brief and designation of matter, in light of the malfunction of counsel's computer server. Encore requests the same 14-day extension so that the parties' briefing schedules will be the same.


