Horizontal Gaze Nystagmus

Left Right Would not follow
 0 0 Lack of smooth pursuit
 0 0 Distinct Nystagmus at maximum deviation
 0 0 Onset of Nystagmus prior to 45 degrees
 0 0 Vertical Nystagmus (Not standardized)
 Instruction

The Walk & Turn Test

- 0 Cannot keep balance while balancing to instructions
- 0 Starts before instructions are finished
- 0 Stops walking to steady self
- 0 Does not touch heel to toe
- 0 Loses balance while walking Steps off the line
- 0 Uses arms for balance while walking (raises arms over six inches)
- 0 Loses balance while turning, turns incorrectly
- 0 Incorrect number of steps
- 0 Suspect cannot perform the test

One-Leg Stand Test

- 0 Sways while balancing
- 0 Uses arms to balance (raises arms over six inches)
- 0 Hopping
- 0 Puts foot down
- 0 Suspect cannot perform the test (puts foot down 3 times)
