I am sorry that you haven't received a satisfactory response. By way of information, when the Division of Appellate Defense requests a transcript, I assume that they are your legal representative. That office has been writing to us each month to ask about the status of the transcript. Upon receipt of these inquiries, my office contacts the court reporter so that we can provide their response to the inquiry. We have been waiting for responses to our inquiries that have gone unheeded from Ms. Hiskell as well. After reviewing this situation, it appears that the transcript is not yet completed and further, that no extensions have been requested.
