2 Friday, November 16, 2012.)

3 BAILIFF: State your name, please.

4 MR. WOOTEN: Thomas Wooten.

5 WHEREUPON, THOMAS WOOTEN

6 AFTER BEING DULY SWORN TESTIFIES AS FOLLOWS

7 MR. WOOTEN: Yes, sir.

8 AGENT SUMTER: Your Honor, the victim in this case was
9 here earlier today. May I ask if the victim is still here or
10 not?

11 THE COURT: You may.

12 (PAUSE.)

13 AGENT SMITH: She is here, but she does not wish to
14 address the Court.

15 Your Honor, this is the case of Thomas Wooten, he was
16 sentenced under Indictment 2012-GS-43-00371 for the offense of
17 indecent exposure.

18 His present violations, Your Honor, Mr. Wooten violated
19 condition number four by having contact with his girlfriend's
20 minor children. Mr. Wooten has admitted that he has had
21 contact with his girlfriend's minor children. He violated
22 condition number nine by not staying at his approved residence
23 every night. He has been staying with his girlfriend --

24 THE COURT: -- He was around her minor children?

25 AGENT SUMTER: Yes, sir. For the last five months. And

1 then, Your Honor, violated condition number four, computer use
2 agreement by using a computer to further his sexual activity.
3 He sent a photograph of a picture of himself by email to a
4 female on September 3, 2012, and that picture is in your
5 package, Your Honor.

7 MS. BUTLER: Yes, Your Honor. Mr. Wooten is currently
8 engaged. His fiancé does have children. He says he is never
9 around the children without her being present. And she also
10 wrote a letter. She wanted to be here today, but she wrote a
11 letter to have you read instead.

12 He does not live with his girlfriend. He has his own
13 residence. He admits to maybe staying there a couple of nights
14 a week. But he has his own separate address.

15 As far as the picture, Mr. Wooten says, he did send the
16 picture by email. It was in his email. However, he does not
17 belong to any chat-rooms, he is not on Facebook, and he is --

18 THE COURT: -- He sent that picture to a person under
19 eighteen?

20 MS. BUTLER: Your Honor. It was part of a email, but he
21 wasn't on any pron sites, he wasn't on any chat-rooms, or
22 Facebook or anything. He has been reporting, and other than
23 that this, I believe, is his only violation.

24 THE COURT: What was he thinking? He knew he was not
25 suppose to be around kids. He knew that. Judge Cothran

1 actually cut him a break in the beginning, and then he goes and
2 shares this picture on the internet of him. What am I suppose
3 to do? I do not have a choice in this matter. You are a
4 convicted sex offender, and you are still offending. I have no


