



1. Lyman R. Rea has been a resident of Greenville County, South Carolina since about 1985.
2. The other plaintiffs listed are family members of Lyman R. Rea.
3. The actions of the defendants toward the plaintiff occurred within the boundary of Greenville County, South Carolina.
4. The Court has jurisdiction in this action and venue is proper.
5. The plaintiff, Lyman R. Rea, asks for a trial by jury.

(COMPLAINT OF THE PLAINTIFF)

1. The plaintiff, Lyman R. Rea, alleges that he was subjected to cruel and unusual punishment for some part of some 14 months by the following:
  - a. Prescription glasses taken away from 2/18/2010 to 4/13/2011 (some 14 months).
  - b. Toiletry bag not distributed from 2/18/2010 to 11/1/2010 (some 8½ months).
  - c. No hand or liquid soap provided from 2/18/2010 to 6/18/2010 (some 4 months).

- d. No modest shower facilities provided from 2/18/2010 to 6/18/2010 (some 4 months).
  - e. Underwear kept from the plaintiff from 2/19/2010 to 11/15/2010 (some 9 months).
  - f. No correspondence pack provided from 2/18/2010 to 11/1/2010 (some 8½ months).
  - g. No footwear given from ap. 2/19/2010 to 6/18/2010 (some 4 months).
  - h. An intimidator was periodically sent by the plaintiff's room to bang on the window from ap. 12/7/2010 to 3/21/2011 (some 3½ months).
2. The plaintiff, Lyman R. Rea, alleges that he was subjected to false arrest on 2/18/2010.
  3. The plaintiff, Lyman R. Rea, alleges that he was falsely imprisoned from 2/18/2010 to 4/13/2011 (some 14 months).
  4. The plaintiff, Lyman R. Rea, alleges that his Miranda rights were violated in that his rights were not read to him at the time he was handcuffed nor was he informed as to the charges against him on 2/18/2010.
  5. The plaintiff, Lyman R. Rea, alleges that his religious rights were violated in that his New Testament that he had on his person when he was handcuffed was taken away from 2/18/2010 until ap. 6/18/2010 (some 4 months).



1 THE COURT: Oh, he's out?

2 MR. ANTLEY: He's in Missouri, I believe.

3 THE COURT: Oh, is he?

4 MR. ANTLEY: Yes, sir. So if y'all will  
5 pay for the flight, I'll be happy for the  
6 transport.

7 THE COURT: Did you notify him of the ---

8 MR. ANTLEY: I did, Your Honor. I've got  
9 something for y'all on that.

10 THE COURT: What time was this one?  
11 10:30?

12 MR. ANTLEY: Yeah. I may be -- I guess  
13 we're on time.

14 THE COURT: So we're not early.

15 MR. ANTLEY: Your Honor, we sent it to

25 when he signed his pleadings even, it was Lyman

1 Russell Rea, 571 Perry Avenue, Greenville, South  
2 Carolina; and it says under that, care of that  
3 Pittsburg, Missouri address. So Your Honor, we've  
4 sent it everywhere we know to send it to him, and  
5 to the address is where he has provided his  
6 information on his own pleadings, so it's the only  
7 information the Court has, as well. I don't know  
8 how else to notify him?

9 THE COURT: When did he file this?  
10 January of '11. Or '12. It was just filed in  
11 January.

12 MR. ANTLEY: Yes, Your Honor, that's  
13 correct. I have not even answered. I opted to  
14 file this motion instead for a motion to dismiss.

15 THE COURT: So did you send the letter to  
16 -- let's see, you sent it May the 30th. So in  
17 plenty of time.

18 MR. ANTLEY: Yes, Your Honor, I sent it  
19 as soon as we got the notice, essentially.

20 THE COURT: And you've not heard from him  
21 at all?

22 MR. ANTLEY: Not this time, Your Honor.  
23 I've got several -- everything I've sent to the  
24 Greenville address throughout the case has been  
25 yellow, come back, ---

1                   THE COURT: You haven't heard anything  
2 from the Missouri address?

3                   MR. ANTLEY: No. But I haven't had a  
4 returned envelope either from the Missouri address,  
5 which is at least some evidence that it's being  
6 picked up there.

7                   THE COURT: All right. Mr. Lopez, have  
8 you heard anything from Mr. Rea?

9                   MR. LOPEZ: No, sir, I have not. The  
10 Court sent notice to that address in Missouri.

11                  MR. ANTLEY: He could possibly be -- I  
12 mean there's people out there right now. I  
13 sincerely doubt ---

14                  THE COURT: Where is Mr. Ford? We'll get  
15 Mr. Ford to go sound his name outside. I don't  
16 guess he's in a different courtroom.

17                  MR. ANTLEY: In his first lawsuit, he  
18 included Brian Williams and NBC News, so ...

19                  THE COURT: Okay.

20                  MR. LOPEZ: I sounded three times and  
21 there was no response.

2 Did you tell him what time the hearing was?

5 Normally we do, but I don't want to make a

7 THE COURT: The letter I have just says  
8 it'll be on June the 18th.

9 MR. ANTLEY: That's true, Your Honor.  
10 There's a -- this is -- okay. That was a follow-up  
11 letter, Your Honor. Let me show you what --  
12 originally the hearing had been scheduled for May  
13 10th, 2012. And I didn't make a copy of this  
14 because I didn't think about this. This is the one  
15 where we told him it had been rescheduled to June  
16 18th at 9:30 a.m.

17 And so my secretary, I think, probably when we  
18 got closer, I just said, look, because this guy is  
19 like 99.9 percent no-show, let's just send him an  
20 additional letter and remind him that he's got a  
21 hearing that day.

22 So the May 30th letter actually, you're right,  
23 did not include a time. It did include, though,  
24 the day and your name as the judge. But we had  
25 previously sent another letter when it was moved --

1 when the hearing itself was moved in which we gave  
2 him all that information, Your Honor. We sent it  
3 again to the same address and the same method,  
4 receipt back, return receipt -- no return receipt,  
5 but just a yellow sender, person not there to take  
6 it, and then to Missouri and it came back as I said  
7 -- it didn't come back as if I mailed you a letter
