Thank you for your letter of December 27, 2012. On June 22, 2012, the transcript of the proceedings in this case was ordered from the court reporter, Ms. Deborah E. Everett. On June 25, 2012, we were informed that Ms. Everett was no longer registered as a court reporter with the Office of Court Administration for the State of South Carolina; therefore, per advice of Ms. Tammy Brown of the Office of Court Administration, we requested the transcript of the proceedings from the Office of Court Administration on June 25, 2012.
