NOTICE OF APPEAL

Ward, LLC, hereby appeal the order of the Honorable Maite D. Murphy dated January 22, 2019
("First Order") granting Respondents Shelly Leeke Law Firm, LLC, and Shelly Leeke's Motion
to Enforce Settlement, attached as Exhibit No. 1, and the order of the Honorable Maite D. Murphy

dated February 22, 2019 (“Second Order”) Denying Appellants’ Motion for Clarification of the January 22, 2019 order, attached as Exhibit No. 2.

Appellant’s Motion for Clarification was treated by the Circuit Court Judge as a Motion to Reconsider the First Order. Appellant’s Motion for Clarification was filed on January 1, 2019, ten days after the First Order was filed. Consequently, it is a timely Motion to Reconsider under Rule 59(e), and extended the time to appeal the First Order. Even if the Motion to Clarify did not extend the time to appeal the First Order, Appellant’s seek appellate review of the Second Order standing alone.


