Dear Ms. Carter:

Thank you for speaking with me this morning. This case ended in the Court of Common Pleas for Orangeburg County on January 14, 2019. Having received no appeal within thirty days, I prepared on February 22, 2019, to submit a final invoice in the case. As Ms. Singletary has previously filed an item without serving me during the pendency of the Common Pleas case, I decided I should check the C-track system to be sure no appeal had been filed. I discovered at that time that Ms. Singletary had filed an appeal on February 13, 2019.

The Notice of Appeal was never served upon me, nor my associate, as counsel for the Town of Holly Hill. The Court will note the "Amended Proof of Service" does not state that a copy was served upon me. That item states, instead, that the Notice of Appeal was filed with the "Orangeburg County Clerk of Court" by "hand delivery" of a copy addressed to the Circuit Court Judge, Edgar W. Dickson, at a "Post Office Box" address. While the cover letter includes a "cc" notation with my name and address, I state on my honor as an officer of the Court that I have not, to this moment, received a copy of any Notice of Appeal from Ms. Singletary. Additionally, I enclose a copy of the "actions" screen for this case in the Court of Common Pleas. Please note there is no indication the Notice of Appeal was actually submitted to the Orangeburg County Clerk of Court, and I assert mailing or hand delivering it to the Circuit Judge does not suffice, even if that actually occurred.

Additionally, I note the Notice of Appeal does not include a copy of the appealed Order. The case was dismissed on August 27, 2018, in the Court of Common Pleas. A Motion to Reconsider was filed and was denied by Order issued January 14, 2019. The Notice of Appeal states the appellant received the Order on January 14, 2019. I assert the Notice of Appeal was not timely served, is defective (lacking the appealed Order, failure to timely serve, failure to timely pay the

filing fee), and should be dismissed.
