no longer represented me" and

I then called the Court of
Appeals office and spoke to a

Defender's office told me and
how unpolite he talked to me.

Jacquelen further explained to me
that the Public Defender was supposed
to represent me until the case

After Jacquelen told me that I needed to ask my attorney to "File a motion to keep the appeal open before March 7, 2019. then

I once again called the Public Defender's office and Mr. Crawford re-iterated that "Their office no longer has anything to do with me," that "it is a done deal".

During this whole situation I may have talked to Ms. Wilson a total of 20 minutes. During which time she made me feel that I had to take one plea or the other. I chose the offer that I thought was the lesser of the two evils. She said that the only thing I could reply to the judge was "Yes sir".

I now realize that I should have pleaded Not guilty. The fire that got started was truly an accident, Not on purpose.

I do not want to live the rest of my life labeled a "felon". That being a felon takes away far too many constitutional rights as well as freedoms and privileges that a non-convicted citizen has.

I feel that I have been publicly shamed. I feel even worse that my daughter's have overheard talk that their mom has committed a major crime. It is a label that will haunt me and make me feel bad the rest of my life no matter where I go or what I do.

I ask of the Court that this matter be pardoned and see the mishap for the accident that it was and not label me with such conviction.

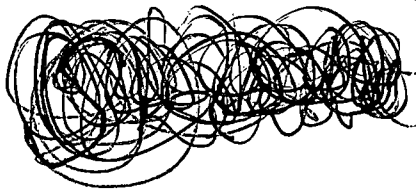
