Court,

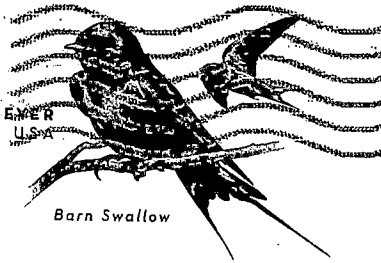
Judge Beatty Will You also explain to Me, Why the Courts Keep ON Appointing
