STATE OF SOUTH-CAROLINA.

To all to whom these Presents shall come, Greeting:

KNOW YE, That for and in consideration of *Forty five*  
*Pounds 5/4* Sterling Money paid by  
*Martha Samways Minor Heir at Law to Henry Samways*  
into the Treasury for the use of this State, We have granted, and by these

Presents do grant unto the said *Martha Samways her*  
Heirs and Assigns, a Plantation or Tract of Land containing

*one thousand nine hundred & forty* Acres  
being the surplus contained in a grant for the *Stolly*  
*Islands* heretofore granted to *William Purvis* on the 9<sup>th</sup>  
of September 1696 for *seven hundred acres or thereabouts*  
but upon a survey found to contain within the lines of  
the same *two thousand six hundred and forty*

having such Shape, Form and Marks, as are represented by a Plat  
hereunto annexed, together with all Woods, Trees, Waters, Water-  
courses, Profits, Commodities, Appurtenances, and Hereditaments,  
whatsoever thereunto belonging, To have and to hold the said Tract of

*one thousand nine hundred & forty*  
Acres of Land, and all and singular other the Premises hereby granted  
unto the said *Martha Samways her*  
Heirs and Assigns for ever, in free and common Soccage.

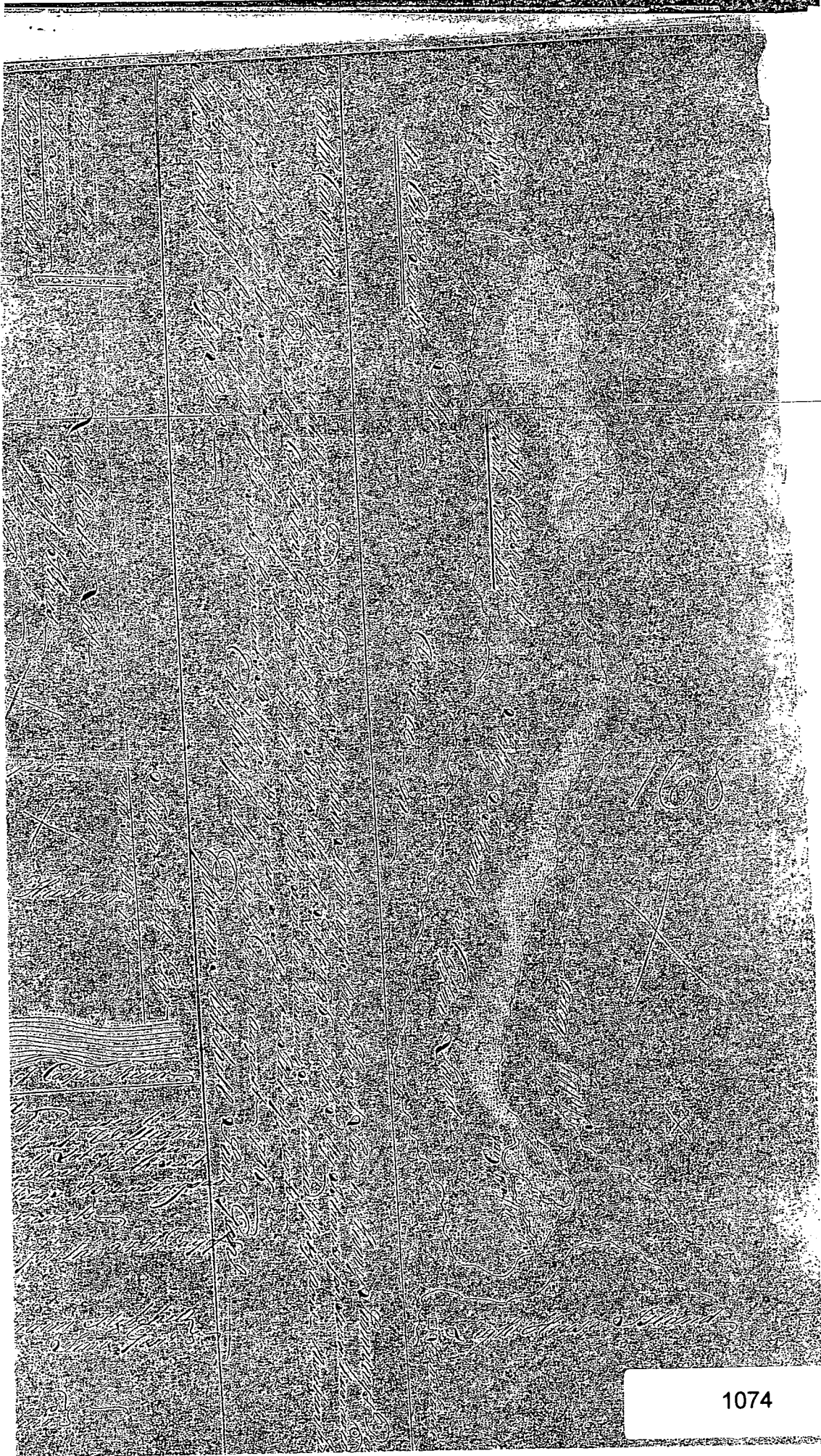
