AFFIDAVIT OF CAROL E. KIRBY

I, Carol E. Kirby, after being duly sworn, do hereby state and affirm the following:


1. I am and have been a property owner in Litchfield Plantation since 2005.
2. On February 2, 2011, I and four other members of an informal committee elected by property owners in Litchfield Plantation met with E. Scott Trotter, who was then a governor and President of Litchfield Plantation Association and a governor and President of Litchfield Plantation Company. At that meeting Mr. Trotter provided me with a list of property owners who had not paid their annual assessment. A true and accurate copy of said list is attached hereto as Exhibit A.
3. I personally sent by email or hand delivered the Notice of the Special Meeting and package of materials attached hereto as Exhibit B to the following persons who owned property in Litchfield Plantation on the stated dates: Walt and Susan Taylor: February 8, 2011; Louise Parsons, Debbie Cockrell, Cindy Muldrow, Phillip and Mary Culbertson: February 9, 2011; Allan Kidston: February 15, 2011.
4. At the Special Meeting of Property Owners held on February 26, 2011, Mr. Logan Trotter submitted a written ballot for the election of persons to the Litchfield Plantation Association Board of Governors. A true and accurate copy of said ballot is attached hereto as Exhibit C. I advised Mr. Logan Trotter that the eleven (11) votes he had cast on behalf of Legacy Place lots could not be counted because assessments due on those lots were more than sixty (60) days in arrears. I further told him that his father, Mr. Scott



Trotter, had provided me with the list showing that assessments had not been paid on the Legacy Place lots and were more than sixty (60) days in arrears. The list I referenced to Logan Trotter is the same list attached hereto as Exhibit A. The Amended and Restated ByLaws of Litchfield Plantation Association, Inc., Article IV Membership, Section 3, states: "Each Class "A" member shall be entitled to one (1) vote for each Lot owned. Provided, no Owner shall have a vote if the Owner is more than 60 days in arrears with respect to all money owed to the Association by that Owner."


