NOTICE OF APPEAL

NOTICE is hereby given that and Plaintiff-Student-Appellant Above- Named, hereby appeals to the Court of Appeals of South Carolina the Order of Dismissal entered in the above captioned case on December 28, 2018.

Motion for Extension of Time to file a Motion for Reconsideration was filed approx., January 7, 2019. The Plaintiff- Student- Appellant has received no emails showing an E-File. No action has been taken by any Administrative Order entered in the above case.

Pursuant to ALC Rule 29, D (2) the administrative law judge shall act on the motion for reconsideration within thirty (30) days after it is filed if an opposing party does not file a response or within thirty (30) days after an opposing party files a response. If no action is taken by the administrative law judge within the applicable period, the inaction shall be deemed a denial of the relief sought in the motion.

Rule 29, D (2); if no action is taken by the Administrative Law Judge within the applicable time, the inaction shall be deemed a denial of the relief sought in the Motion, Order or Other Action.

Pursuant to ALC Rule 29 D (4) the time for appeal for all parties shall be stayed by a timely motion for reconsideration, and shall run from receipt of an order granting or denying such motion. If no order is filed regarding the motion, the time for appeal shall begin to run thirty (30) days from the date the motion is deemed denied pursuant to subsection D (2)

The (30) days from the date the motion is deemed denied shall end February 7, 2019. Therefore the time for appeal shall begin to run until March 7, 2019.

This Notice of Appeal is compliant to ALC Rule 29 D (4).

However, the filing of a Motion for Reconsideration is not a prerequisite for filing a Notice of Appeal.

The Clerk will please omit the following from the Record on Appeal:

1. Defendant Agency's Pretrial Motion to Dismiss.

2. Defendant Agency's Exhibits, from the Court of Common Pleas, attached to his Prehearing Statement.

Transcript of evidence and Proceedings pertaining to the ALC Rule 17 Scheduling Conference will be filed for inclusion in the record on appeal.

This Court rather than the Supreme Court of South Carolina has jurisdiction of this case on appeal for the reason that subject matter is given pursuant to South Carolina Code 1-23-380; ALC Rule 31.
