

Please find enclosed for filing a Notice of Intent to Appeal and Proof of Service in the above-mentioned matter. Please file the original and return a clocked, certified copy to me in the enclosed self-addressed, stamped envelope.

On October 17, 2018, Defendant was convicted of Murder (Indictment No.: 00200) and Armed Robbery (Indictment No.: 00201) and sentenced to forty (40) years and thirty (30) years, respectively. The sentences were to run concurrently. On October 25, 2018, Defendant filed a timely post-trial motion for a New Trial based on insufficient evidence and a motion to Reconsider Sentence. These motions were not heard prior to The Honorable Doyet A. Early, III, retirement.

In order to preserve the Defendant's right to appeal, I am filing the Notice of Intent although the post-trial motions are still pending.
