This matter comes before the Court pursuant to the Defendant's Motion to Stay the Previous Ruling of the Court. At the hearing in this case, the Court requested that Mr. Julien present a Financial Declaration or other financial statement, duly notarized, demonstrating his financial condition. This Court was clearly willing to consider the Defendant's position if in fact he could demonstrate indigency or significant financial depression.
