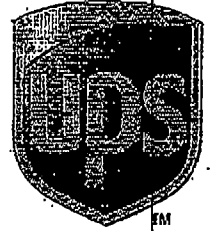



MEMORANDUM


As requested by the clerk of court, on January 28, 2019 appellant sent this court an Amended Record on Appeal correcting several errors in the original. On or about March 7, 2019 the clerk of court sent appellant another letter requesting that appellant file a second amended record on appeal, citing errors in the caption and in numbering of the original.

However, appellant submits that the amended caption is in compliance with SCACR Rule 267 (a) specifically where the name, address, and phone number of both the appellant and the only counsel of record for the respondent appear thereon. A copy of the amended caption is attached hereto.

Second, where errors in page numbering were cited by the clerk, appellant submits that the page numbers of the amended record are consecutively numbered except for the redacted pages at the end. 


