
At a Court of General Sessions, convened on May 10, 2018, the Grand Jurors of York County present upon their oath:

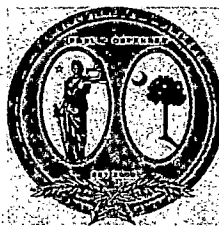

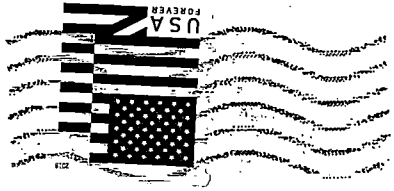
