




On January 21<sup>st</sup> 2009, The appellate filed in the Court of Common Pleas, and was denied w/prejudice, the State of South Carolina Supreme Court decision in Earl Bennett vs. State opinion no. 26565. The appellate argued that he did not receive time served under the original conviction sentencing of the General Session Court ORDER of Judge Rawls. The Appellate also raise to the Court that he did not commit a physical crime of sexual intercourse.

After being Released from a full revocation,, the Appellate was violated for the Standard Conditions of Probation w/the CPS, program and was detained. This detention, however created a time laps on appeal and created three other full revocation Orders.


Upon six month being released from the Order of the General Session conviction, the Appellate was detained, a few hours later after his release, arrested, and placed back under the General Session ORDER of 1999, for one year and six month of additional probation.
