

Comes Now the Appellant above named who hereby would respectfully move the Most Honorable Court to appoint private counsel to represent Appellant in this pending PCR appeal .




AFFIDAVIT OF INDIGENCY

- 8) I do not receive any prison pay ;


I declare under the penalty of perjury that the above statement is true and correct and that I can be subjected to criminal prosecution for any false statements given herein .


