MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR
WRIT OF CERTIORARI AND APPENDIX

Counsel for Edward M. Dunn respectfully requests an extension of thirty (30) days in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Deandre Tyshun Foster v. The State with this Court on March 1, 2019. Counsel filed the petition for rehearing in the case of The State v. Michael Taquarius Rencher with the Court of Appeals on February 27, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Marcus Willis Thames v. The State with this Court on February 19, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Sherra L. Werkmeister v. The State with this Court on February 15, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Barrington Wayne Grant with the Court of Appeals on February 1, 2019.


4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.


WHEREFORE, the undersigned counsel would respectfully request a thirty day extension, in which to file the Petition for Writ of Certiorari and Appendix in this case based




