The United States District Court for the District of South Carolina certifies the question of law set forth: I. Certified Question of Law Does the three-year statute of limitations of S.C. Code Ann. § 15-3-530 apply to claims for promissory estoppel? The Court concludes that the answer to the question certified herein may be determinative of a cause of action in this case, and there is no controlling precedent in the decisions of the Supreme Court of South Carolina.
