MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF CERTIORARI AND



filed a petition for rehearing in the case of State v. Alton Jamaul Crosby in the Court of Appeals on February 7, 2019.


4. Counsel makes this request in good faith and not for purpose of delay.




