

NOTICE OF APPEAL

The State of South Carolina hereby appeals to the Court of Appeals the Order of the Honorable Daniel D. Hall, made in open court on March 14, 2019 and memorialized in a final written Order Granting Relief issued on March 29, 2019. Judge Hall ordered that the Defendant should not be remanded back into the custody of the South Carolina Department of Corrections (SCDC) to serve the remainder of his active sentence. The Defendant had previously been released in error by SCDC but his sentence was still active and had not been served and/or satisfied at the time of the hearing and final order. Judge Hall's final written three page order is attached to this appeal.



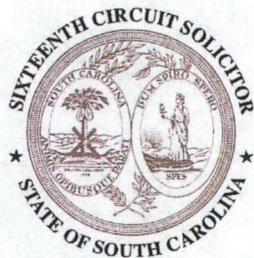
