

Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Ashley McKenzie with the Court of Appeals on February 11, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Terrell Freeman with the Court of Appeals on February 6, 2019.

3. As indicated by his consent below, counsel for the state does not oppose this request.




