

Isaac Adams appeals his guilty plea and sentence in this case. Mr. Adams pled guilty on March 25, 2019 to Strong Arm Robbery and Grand Larceny, value more than \$2,000 but less than \$10,000 before the Honorable Diane S. Goodstein. Mr. Adams was sentenced to ten (10) years suspended to two (2) years probation for the Strong Armed Robbery, to five (5) years suspended to two (2) years probation on the Grand Larceny, value more than \$2,000 but less than \$10,000. The sentences were to run concurrently.




