

Isaac Adams (Appellant) appeals his guilty plea and sentence in the aforementioned case. Appellant pled guilty on March 25, 2019 to Strong Arm Robbery and Grand Larceny, value more than \$2,000 but less than \$10,000. The court accepted Appellant's guilty plea. Appellant was sentenced ten (10) years suspended to two (2) years probation for the Strong Armed Robbery, to five (5) years suspended to two (2) years probation on the Grand Larceny, value more than \$2,000 but less than \$10,000. The sentences were to run concurrent. Undersigned counsel is filing this appeal at the request of Appellant, and pursuant to State v. Thrift, 378 S.C. 70, 661 S.E.2d 373 (2008), Weathers v. White, 319 S.C. 59, 459 S.E.2d 838 (1995), and In re Anonymous Member of the Bar, 303 S.C. 306, 400 S.E.2d 483 (1991). Counsel knows of no issue that can be reviewed on direct appeal.






