
Dear Honorable V Claire Allen:

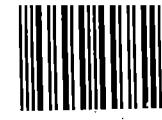
