October 21, 2015

On February 13, 2015, 2 sleeves of frozen dairy samples were received from South Carolina Department of Health, Division of Food Protection and Rabies Prevention, Dairy and Manufactured Foods as part of the State MFRPS-ISO Sampling Agreement. The samples were collected from one distribution center in Lexington County in Lexington, South Carolina. A total of 60 individual frozen dairy treats were collected. Fifteen treats from each sleeve of samples were tested for *Listeria monocytogenes*. All samples were tested according to modified AOAC VIDAS screening procedures and the U.S. Food and Drug Administration (FDA) Bacteriological Analytical Manual (BAM) procedures.

The results are as follows:

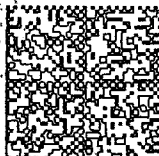
