Ms. Allen:

I am in receipt of a copy of John E. Cheatham's February 25 letter to you regarding the above-referenced matter. I wish to briefly clarify the record regarding my February 8 transmission to Mr. Cheatham, which included a copy of my letter dated February 1.

Mr. Cheatham's letter correctly states that my office mailed a copy of my February 1 letter to his office on February 8. We initially sent the letter to Mr. Cheatham on February 1 addressed to a post office box address he evidently no longer uses. This address appeared in Mr. Cheatham's signature block as recently as November 22, 2017 in filings made in the underlying case. Because all filings in the interim were made using Aiken County's e-filing program, we had no need to send physical mail to Mr. Cheatham's office until we provided him a copy of the February 1 letter. Thus, we did not realize Mr. Cheatham had stopped using the post office box address some time in late 2017 or 2018.

The error was brought to our attention on February 8, when our mailing to Mr. Cheatham's old post office box address was returned to us by the Postal Service. That same day, we re-sent the letter to his current physical address at 102 Harmon Street in Lexington. All future physical communications will be sent to that address and via e-mail.

I have enclosed copies of our envelopes to Mr. Cheatham post-marked February 1 and February 8 and am providing the same to Mr. Cheatham by copy of this letter. I apologize for any confusion this may have caused.

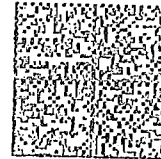

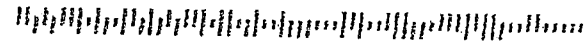
