
REQUEST PERMISSION FOR LEAVE

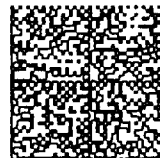
