

NOW THEREFORE on Motion of Plaintiff, with the consent of Robert W. Dibble, Jr., Attorney for the Plaintiff,


IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Thomas J. Thompson is relieved as counsel for Defendant in the above named action, and




