COUNT ONE
MURDER

That **James Lee Ginther** did in Sumter County, on or about **November 16, 2017**, willfully, feloniously, and intentionally kill the victim, Suzette Ginther, with malice aforethought, either express or implied, by shooting the victim in the head and burying her body in a wooded area, and the victim did die as a proximate result thereof on or about November 16, 2017 in Sumter County, in violation of Section 16-03-0010, S. C. Code of Laws, 1976, as amended.

COUNT TWO
KIDNAPPING

That **James Lee Ginther** did in Sumter County on or about **November 16, 2017**, unlawfully seize, confine, inveigle, decoy, kidnap, abduct or carry away one Suzette Ginther, without authority of law, in violation of Section 16-03-0910, S. C. Code of Laws, 1976, as amended.
