The multiple Officers on the Property armed and yelling at the front door & back door they were going to use force if my Dad & Daughter didn't open the door. The signs were posted at each gate No Trespassing For Any Reason. I feel that if they were going to disobey the Appeal they should've giving us Notice especially if they didn't come on the order date. I'm having to write everything by hand because along with other property my computer isn't working at this time. I'm not mentally ready to really be in the public eyes. I've had to go to the Library a few weeks ago to use the computer and I wasn't comfortable in doing that when I had to. I haven't really done a lot since this disturbing day. If you look for or may I say if you're looking for something more formal it may be a while. I had started some typing of a Private, Special, Privileged Confidential Excluding the Public and Press, Special Term, Not General, etc. I also started a Original Bill in Equity to Proceed Special Term, Sealed, Ex Parte In Camera hearing, Sealed, Private Chambers, In Camera Hearing. I and my Family would be happy if you would Order that we return to our Home without Public Knowledge and Most ~~Definite~~ Certain with Sanction ~~and~~ ~~of~~ of all involved in this Terrible Act. We were in our Home since November 2005. We never bothered anyone. We are a peaceful Family. We helped our neighbors if they were in need of our help. It really hurt the neighbors that day as well to see what was happening to us. We should've never been included in the Territorial Jurisdiction. Please Put the Order in soon for My Family and I to return to our home. We had started renovating our home. We replaced all room ceiling fans, shower to bath tub in master bedroom bathroom, painting, hardwood floors, etc. If we had any earthly idea that these people could treat us like that (Americans) Unbelievable.

I, (We) Helen Valencia Washington - Thomas and Family, Private Civilian National of the United States of America, Private South Carolina National wants it Ordered Immediately that we return to our home 3002 Knightbridge Road Columbia, South Carolina 29223 and that Restitution, sanction and whatever else this court see fits to be done to all that were involved on this devastating day Monday 28 January 2019; to Private Civilian Nationals of the United States of America. Everyone had been properly notified. I have included a copy of the Registered Mail Return Receipt that was sent to the Richland County Sheriff Department Sheriff Leon Lott Attention I have also included the ^{copy} documents sent to Sheriff Leon Lott. The Law Office of Brock and Scott, PLLC Attention to Chad W. Burgess South Carolina Bar No. 72520 was also Notified that an Appeal was filed on the order made by The Honorable Joseph M. Strickland Richland County Court Case No. 2012 CP 40 00009. 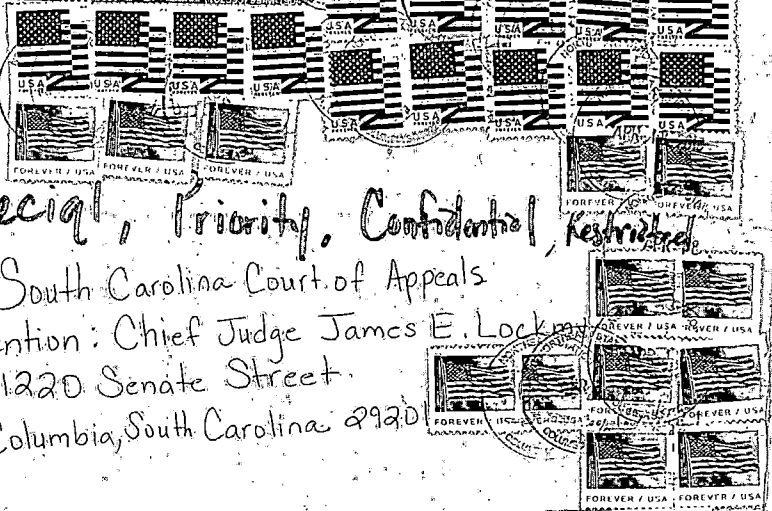
