

On September 30, 2014, SCHAC commissioner, Raymond Buxton, II made determination on case number 04-14-0292-8.

We studied and analyzed the first page of this determination; the following is our report:

1. "property in question is not exempt under the application statutes". "If proven, the allegation would constitute a violation of section 804..."

In order to prove SCHAC conclusion is right or wrong, had SCHAC checked with Charleston County concerning Stuart Engals Blvd 1465 is commercial building or apartment building?

Charleston county always told us that 1465 Stuart Engals Blvd is commercial building as a physician office.

2. "Complainant asserted she responded to an advertisement for 2-bedroom unit."?

Yolanta did advertisement on craigslist as room for rent, she never advertised 2-bedroom unit and she never said 2-bedroom unit. 2-bedroom unit advertisement was fabricated by Stacey Woods, SCHAC did or did not investigation?

3. "Yolanta is said to have complainant's income verified"?

Yolanta never told Stacey Woods, she verified Stacey income. How can Yolanta with her limited English to verify Stacey Woods income and Stacey woods family financial information within 1 to 2 minutes phone call during very busy working hour? Tenant income is one of most important questions for tenant to rent. Only after Stacey view room, fill out application form, exam Stacey Woods income and her family financial information, Stacey Woods income can be verified. However, Stacey Woods decided not to come for application, refuse view room.

SCHAC decided to believe Stacey Woods fabricated story.

4. "and set appointment for complainant to view the dwelling."

According to our experience all the tenant wants to view room, then make his or her decision.

Stacey made appointment during working hour of that day for view the dwelling, but she did not come, she did not call to cancel, she did not reschedule another appointment. Instead, Stacey Woods drove to our parking lot in the dark evening time.

We want to know, if SCHAC does have its own office hour? Every business has business hour.

5. "Complainant alleged she met Yolanta (white) and an Asian male (believed to be property owner) at the unit."

Stacey Woods emphasized Yolanta (white), and Asian male, Stacey Woods African American, and SCHAC Marvin Caldwell always focus on skin color. Stacey Woods Drove to our parking in evening time without appointment.

SCHAC commissioner's determination maybe was based on Marvin Caldwell's work, this conclusion was not correct.


The case lasted more than 63 months, but SCHAC using tax payer money and public resources to continue this legal fight for protecting the criminal behavior and action of Stacey Woods.
