Count 8. Also Title 42 Chapter 21. All persons within jurisdiction of the United States shall have the same rights in every state.


Count 9. Give me a reason why this case cannot be granted to me.

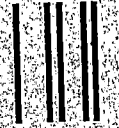


