


Dear Ms. Kitchings:

On October 17, 2018, Defendant was convicted of Murder (Indictment No.: 00200) and Armed Robbery (Indictment No.: 00201) and sentenced to forty (40) years and thirty (30) years, respectively... The sentences were to run concurrently. On October 25, 2018, Defendant filed a timely post-trial motion for a New Trial based on insufficient evidence and a motion to Reconsider Sentence. 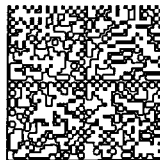
