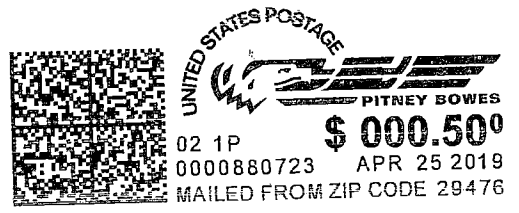

My original P.C.R. C/A # 2009 Order of dismissal CP-32-2479, was on September 24th 2014. My rule 60(b)(3) C/A # 2015, CP-32-0570 was filed February 12, 2015 see exhibits (I) and (II) Rule 60(b)(3) RULES OF CIVIL PROCEDURE states the motion shall be made within a reasonable time and for reasons (1)(2) and (3) not more than one year after judgment, order or proceedings was entered or taken. A motion under this subsection (b) does not affect the finality of a judgment or suspend its operation. This rule does not limit the power of a court to entertain an independent action to relieve a party from a judgment, order, or proceeding, or to set a judgment from fraud upon the court. My original P.C.R. Application C/A # 2012 CP-32-2479, was not filed raising the issues of ineffective assistance of counsel. See Exhibit (III) My P.C.R. Counsel never amended my P.C.R. Application to include the ineffective assistance of counsel issue. See P.C.R. Transcript.
