Respondent, through its undersigned attorney, would respectfully show as follows:



3. The undersigned has consulted with counsel for the Appellant, and she is authorized to advise the Court that counsel consents to the requested relief.


Based on the foregoing, Respondent respectfully requests this Court hold this matter in abeyance pending a resolution of this motion, and grant the Respondent the requested relief.


